- \*\* Comply with temporary food establishment requirements of the Fort Worth/Tarrant County Public Health Department – *see below for further details.*

*Participants are encouraged to decorate the booth and promote their establishment by handing out menus, holiday party information or discount coupons.*

## Restaurant will receive:

- \* One 10' x 10' booth with back draping and 3' side drapes.
- \* One skirted 6' table with two chairs.
- \* One 7" x 44" company name sign.
- \* Electrical outlets (110 & 220) are located every 20'-30' feet. (Restaurant must provide their own extension cords.)
- \* Business listing in the Trade Show program.
- \* Acknowledgement of your participation in the *Chamberletter*.

\*\*All Health Department requirements regarding food and beverage protection, handling certification, personnel, utensils, proper set-up and waste are the **sole** responsibility of the vendor at the trade show. ***A representative from the Fort Worth/Tarrant County Public Health Department will be present at the event to verify vendor requirements.*** However, the vendor's temporary Health Department permit fee will be provided for under a blanket permit for a temporary event purchased by the Fort Worth Chamber of Commerce from the Health Department.
